Harassment, intimidation or bullying means any gesture, any written, verbal or physical act or any electronic communication, whether it is a single incident or a series of incidents, that is:
reasonably perceived as being motivated by either any actual or perceived characteristic, such as race, color, religion, ancestry, national origin, gender, sexual orientation, gender identity and expression or a mental, physical or sensory disability or by any other distinguishing characteristic; <b>AND THAT</b>
takes place on school property, at any school-sponsored function, on a school bus, or off school grounds, as provided for in N.J.S.A. 18A:37-15.3 that substantially disrupts or interferes with the orderly operation of the school or the rights of other pupils; <b>AND THAT</b>
a reasonable person should know under the circumstances will have the effect of: physically or emotionally harming a pupil; <b>OR</b>
damaging the pupil's property; <b>OR</b>
placing a pupil in reasonable fear or physical or emotional harm to his/her person or damage to his property; <b>OR</b>
has the effect of insulting or demeaning any pupil or group of pupils; OR
creates a hostile educational environment for the pupil by interfering with a pupil's education or by severely or pervasively causing physical or emotional harm to the pupil.
Any deliberate false report will be addressed as a violation of the law.
