School Description and Mission Statement

Wangenheim Middle School is located in Mira Mesa and proudly draws close to 1,000 students, primarily from the Mira Mesa community. Students at Wangenheim include a diverse blend of languages, cultures, ethnicities, socioeconomic backgrounds, and learning styles. Teachers at Wangenheim support and assist students to meet high academic expectations. Wangenheim participates in the district's School Choice program, which allows students from various communities within San Diego to elect to attend the school. Approximately 30 students attend through School Choice.

The mission of Wangenheim Middle School is to educate all students to become productive, responsible, and well-rounded lifelong learners by creating a positive school culture of cohesive stakeholders (parents, staff, community, and students). To achieve our goals, we emphasize meeting the diverse academic, social, and personal needs of our students. Our goals toward this mission include academic instruction based on Common Core State Standards, a diverse elective program, character education programs, counseling, personal management systems, and providing opportunities for extracurricular involvement.

We also emphasize a positive, integrated, student-centered transition from elementary to high school that stresses high expectations for academic achievement, acquisition of social skills, and responsible behavior.

School Facility Conditions and Planned Improvements (2015–16)

Wangenheim has a large, attractively landscaped, 35-acre campus that is clean and free of graffiti. We take great pride in maintaining a safe and clean learning environment for our students. All buildings and equipment are in excellent condition. Classrooms include six air-conditioned buildings built in 1978. We built 24 new classrooms in 1996, and the rest of the school was refurbished at the same time. At our school, improvements include repainting and re-carpeting of several of our older buildings and improved access for the physically disabled. In addition, we have six new state-of-the-art science labs, a new cooking classroom, and one new multiuse classroom. We will continue to use money from bond issues to improve our facilities.

Wangenheim has many special facilities: a wood shop, a metal shop, a video broadcasting studio, an auditorium with tiered seating, a weight room, and an activity room/gymnasium. We also have a spacious athletic field, as well as basketball and racquetball courts. Our media center contains a wealth of resources, as well as two computer labs featuring an excellent array of software. In addition, all of our classrooms are equipped with state-of-the-art i21 technology, including Promethean interactive whiteboards, document cameras, laptop computers or iPads for all students, and video projectors.

Statewide Assessments

CAASPP Assessment Results

The California Assessment of Student Performance and Progress (CAASPP) tests students in English language arts/literacy and mathematics in grades 3 through 8 and grade 11. The CAASPP was piloted in 2013–14 and first administered statewide in 2014–15. CAASPP scores are ranked according to four “performance levels”: Level 1 indicates that the student has not met the standard tested; Level 2 indicates that the student has nearly met the standard; Level 3 indicates that the student has met the standard; Level 4 indicates that the student has exceeded the standard. Students scoring at Levels 3 and 4 have met state standards in that content area.

Note: In the tables that follow the number of students tested includes students who did not receive a score; however, achievement-level percentages have been calculated using only those students who did receive scores.

Career Technical Education Programs (2014–15)

Career Technical Education (CTE) in the San Diego Unified School District is a program of study involving a sequence of courses that integrates core academic knowledge with technical skills. The program provides students with multiple pathways to college and careers. Students complete a career pathway, which includes: (a) two or more CTE courses in a single, defined field of study, (b) passing of the pre- and co-requisites CTE and core curriculum courses, and (c) passing of at least one CTE advanced-level course. The career pathways are organized within the context of the state-defined 15 different industry sectors, which have been identified as critical for the fiscal stability and prosperity of the State of California. Student internships are a required component of the advanced-level CTE course curriculum. CTE programs of study often fulfill the “a–g” subject-area requirements of the University of California and the California State University and may lead to community college credit, an industry-recognized credential, a certificate, or a degree at the postsecondary level.

Courses for University of California and/or California State University Admission

University of California

Admission requirements for the University of California (UC) follow guidelines set forth in the Master Plan, which requires that the top one-eighth of the state’s high school graduates, as well as those transfer students who have successfully completed specified college work, be eligible for admission to the UC. These requirements are designed to ensure that all eligible students are adequately prepared for university-level work. California State University

Admission requirements for the California State University (CSU) include three factors to determine eligibility: specific high school courses; grades in specified courses and test scores; and graduation from high school. Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Campus safety is the district's top priority. Principals, teachers, support staff, school police services, and community organizations work together to prevent, prepare, and respond to emergency situations. To ensure safety and security, each school has a state-mandated individual emergency response plan that is updated annually and posted on the school's website. School staff members participate in regular emergency-preparedness drills and response training. Substance abuse prevention programs are presented to students regularly. Policies and procedures are in place to address safe entry and exit of students; serious disciplinary problems; discrimination, harassment and bullying; mandated child abuse reporting procedures; and school dress codes.

Adult supervision is provided in the classrooms and outside areas before and after school, during recess and lunch, and during passing time between classes. Under the direction of the principal or site administrator, school staff members implement specific school-building security procedures. In addition, district offices support schools by reviewing and disseminating safety requirements and information, coordinating safety-related services, and providing safety training and assistance.

Wangenheim Middle school is committed to supporting a safe and respectful learning environment. Administrators, in partnership with students, parents, teachers, and counselors, implement a strong code of discipline based on respect, responsibility, self-control, and cooperation, which promotes a positive climate for learning. The Positive Behavioral Intervention System, which has been implemented for several years, continues to support students in making responsible academic and behavioral choices that lead to a successful middle school experience and build a strong foundation for high school success.

Campus activities, both curricular and extracurricular, are supervised by administrators and faculty members. Tardy and truancy policies are enforced. Tutoring is provided daily, and teachers provide a year-long schedule of tutoring supports.

Professional Development

The district and the Board of Education have set a high priority on professional development, with the goal of providing targeted professional development to build capacity and knowledge to support student learning success. The Office of Leadership and Learning collaborates with other departments to provide teachers and administrators with ongoing professional development, including improving teaching and learning related to the Common Core State Standards, educational technology, advanced studies, and leadership development. Sessions offered at various times throughout the year focus on a wide variety of professional development aimed at strengthening content knowledge to meet the needs of all learners, with an emphasis on targeting the needs of our English language learners, students with disabilities, and other struggling learners.

In addition to district-provided professional development, principals identify a schoolwide focus each year for professional development and also determine areas of individual need. Throughout the year, teachers participate in school-based professional learning communities (PLCs) to encourage best practices and shared problem solving. Teachers are provided with useful data systems that allow them to improve the learning of each student. Principals also provide the ongoing training needed to be professional site managers. Staff release for professional development is organized in a variety of ways on a site-by-site basis throughout the year.

Professional development is an effective method for maintaining a focus on sustained student achievement. The Mira Mesa secondary cluster schools met within their departments twice a year to better support and communicate with one another to prepare for a seamless

transition to Common Core State Standards (CCSS). This collaboration provided the highest quality education for all children. We emphasize meeting the diverse academic, social, and personal needs of our cluster schools.

In addition, each month literacy, social studies, mathematics, science, and special education teachers engaged in on-site, full-day professional development on the CCSS. The purpose for these monthly sessions included deepening the level of instruction and tasks to align with higher-ordered thinking skills inherent in the new-generation assessments. Teachers infused more critical thinking, collaboration, and student discourse to support college and career readiness. Also, teachers developed common methods for assessing students' ability to access their content standards as well as analyzing performance data to make more informed instructional decisions.
